60's

Luigi, Costante's son, guides Piovan in the market of auxiliary machinery for the plastics industry.

70's

From single units to complete systems with the introduction of the first refrigeration line and central feeding, blending and drying solutions.

80's

Introduction of electronics, partnerships with OEMs and further growth on foreign markets.

90's

The innovation continues by acquisition of a Software House to develop remote plant monitoring and process control.

00's

Nicola, Luigi's son, drives the transformation of the Group from an auxiliaries manufacturer to a turn-key engineering reality. Una-Dyn and Fdm are acquired.

10's

The Group enters the food market and consolidates its position in plastics acquiring Penta, Progema, Fea and Doteco. Aquatech starts its operations in industrial cooling. The Group enters into the FTSE ITALIA STAR INDEX as a Public Company.

In 2021 the Group receives its first ESG Risk Rating issued by Sustainalytics. In January 2022 Piovan has completed the acquisition of IPEG, the U.S. industrial group comprised of the four brands Conair, Thermal Care, Pelletron and Republic Machine.


